

## Contract Agreement (Form e-PW2-4)

THIS AGREEMENT made the 23<sup>th</sup> day of May 2023 between Bangladesh Telecommunications Company Limited, Telejogajog Bhaban, 37/E, Eskaton Garden, Dhaka-1000 (hereinafter called "the Procuring Entity") of the one part and Mohammed Eunos & Brothers (Pvt.) Ltd. Eunos Business Centre, Equity G.F. Fortune Mall (7<sup>th</sup> Fl.), 01 No. Baizid Bostami Road, Nasirabad, Panchlaish, Chattogram City, Chattogram-4000. (hereinafter called "the Contractor") of the other part:


WHEREAS the Procuring Entity invited Tenders for certain wooks, viz, "Plastering, painting and repair of doors and windows of various parts of external and internal areas of telephone exchange and other buildings of Rangpur, Nilphamari, Kurigram, Lalmonirhat, Joypurhat, Dinajpur, Panchogor, Takurgaon district headquarters and Bogura Rest House, Rangpur Rest house, Dinajpur Rest House under the jurisdiction of GM-2 under CGM Northern, BTCL, Rajshahi." (e-Tender ID: 803915) and has accepted a Tender by the Contractor for the execution of those works in the sum of Taka 62,11,301.400 (Taka SIXTY-TWO LAKH ELEVEN THOUSAND THREE HUNDRED AND ONE POINT FOUR only) including all kinds of VAT and Taxes (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the General Conditions of Contract hereafter referred to.
2. The following documents forming the Contract shall be in the following order of priority:
  - (a) the signed Contract Agreement
  - (b) the Notification of Award
  - (c) the completed Tender and the appendices to the Tender
  - (d) the Particular Conditions of Contract
  - (e) the General Conditions of Contract
  - (f) the Technical Specifications
  - (g) the General Specifications
  - (h) the Drawings
  - (i) the priced Bill of Quantities and the Schedules
  - (j) any other document listed in the PCC forming part of the Contract
3. In consideration of the payments to be made by the Procuring Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Procuring Entity to execute and complete the works and to remedy any defects therein in conformity in all respects with the provisions of the Contract.
4. The Procuring Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the works and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.




