THIS AGREEMENT is made on the 30th day of November 2023 between **Bangladesh Telecommunications Company Limited**, Telejogajog Bhaban, 37/E, Eskaton Garden, Dhaka-1000 (hereinafter called “**the Procuring Entity**”) of the one part and **ADN Telecom Limited**, Red Crescent Concord Tower (4th Floor) |17 Mohakhali C/A, Dhaka 1212, Bangladesh (hereinafter called “**the Contractor**”) of the other part:

WHEREAS the Procuring Entity invited Tenders for certain goods and related services , viz, “**Supply, Installation, Testing and Commissioning of BTCL Call Center**” (e-Tender ID: 883563) and has accepted a Tender by the Supplier for the supply of those goods and related services in the sum of Taka 1,17,84,310.683 (**Taka ONE CRORE SEVENTEEN LAKH EIGHTY-FOUR THOUSAND THREE HUNDRED AND TEN POINT SIX EIGHT THREE**) including all kinds of VAT and Taxes (hereinafter called “**the Contract Price**”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the General Conditions of Contract hereafter referred to.

 - (f) Technical Specifications
 - (g) General Specifications
 - (h) Drawings
 - (i) Price Schedules and schedule of Requirements
 - (j) other document including correspondences listed in the PCC forming part of the Contract.
3. In consideration of the payments to be made by the Procuring Entity to the Contractor as hereinafter mentioned, the Supplier hereby covenants with the Procuring Entity to execute and complete the works and to remedy any defects therein in conformity in all respects with the provisions of the Contract.

4. PE hereby covenants to pay the Supplier in consideration of the execution and completion of the works and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.






